## **CALL FOR PAPERS**

International Congress “Aporophobia and Criminal Law” is part of the project **Aporophobia and Criminal Law, funded by the Ministry of Science, Innovation and Universities** (reference: RTI2018-095155-B-C21). The principal researcher is Ana Isabel Pérez Cepeda (University of Salamanca). The **main objective** of this project is to analyse how the criminal law and criminal policy treat marginalised people nowadays, with the final aim of elaborating *de lege ferenda* proposals to improve the current situation.

Therefore, **subject areas** of the papers, which are directed to professors, researchers and PhD students of foreign and national universities, are:

- Criminal policy and y social exclusion.
- Criminology analysis of aporophobia
- Ideological basis of the aporophobic criminal law.
- Criminal law "of the friend" vs. Criminal law "of the enemy"
- Criminalization of trifle crimes
- Criminalization of immigration.
- Criminalization of protest and social movements
- Criminalization of petty drug dealing.
- Others manifestations of the aporophobic criminal law.

Papers will be evaluated by a scientific committee. The recommended extension of the paper is five pages (Times New Roman, 12, single line spacing, citation format in APA). Regarding to international character of the Congress, papers can be written in Spanish or English. **The deadline to send papers is September, 15th, 2020.** The email for receiving communications is [crimensalamanca@gmail.com](mailto:crimensalamanca@gmail.com).

The selected papers will be presented orally and live during the days of the congress. They might last less than ten minutes. It will be necessary to be registered in the Congress. Likewise, all the selected papers could choose to be published in the *Critical Criminal System Journal* after the corresponding review process. For the publication, an article must be sent on the subject matter of paper, which will be between 10 and 15 pages long, in Spanish or English, with the style rules indicated on the following website: <https://crimen.eu/contribuciones/>. The deadline for submission of these works is October, 15<sup>th</sup>, 2020.
